5.0 Reading Financial Statements – Terri Walker

Terri Walker of Haida Gwaii Accounting & Income Tax Ltd presented on how to read the Gwaii Trust financial statements; what to look for, and what to ask the auditor at the end of the year. Presentation included handouts explaining specific items in the Gwaii Trust Dec 31, 2015 financial statement.

6.0 Strategic Plan Review

The acting chair explained the history of the 5 year strategic plan, a draft copy of which was presented. The committee also reviewed a draft copy of the summary report, *Gwaii Trust Society, Strategic Vision at a Glance 2017-2022.*

Opened for discussion with changes to the summary report recommended by committee:

- Changes page 5: Goals/healthy activities reword
 Discussion around language:
 - In response to the Wellness Forums and input from the communities we are taking a more proactive approach
 - In response from islanders we have changed our role by becoming proactive for hg healthy individuals, healthy islands and healthy communities
 - As a result of public input Gwaii Trust intends to pursue...
 - Shift in role from being reactive to proactive on areas that are deemed healthy communities
 - Given the public input sessions, Gwaii Trust feels it can better serve healthy communities on the islands by taking the lead in investigating areas with a more proactive approach in seeking opportunities approach to address some of the islandswide issues.
 - Shift in the Gwaii trust role by becoming proactive on islands-wide issues
