11. PH&N Commercial Mortgage Investments Updates – Actually #12

The Executive Director provided an update on the status of exiting the Commercial Mortgage investment with Phillips, Hager, & North Investment Management due to their inclusion of fossil fuel investments in the cash management portion of the fund. PHN had informed Gwaii Trust that there is a substantial early redemption penalty (\$250,000) if the Trust makes this withdrawal within three years of the initial investment. The Executive Director has requested that this penalty be waived in recognition of the length



of time with PHN, the reason behind the withdrawal and their remaining investments. In response, PHN is exploring the creation of a new fund which would exclude fossil fuels. The Board should know before March 2024 the status of this fund.
