## 7a. Athlii Gwaii Legacy Trust Transfer Agreement

The three trustees representing Athlii Gwaii Legacy Trust - Percy Crosby, Freda Davis, and Maureen Bailey - signed the transfer agreement to move the AGLT property to the Gwaii Trust Society. Upon signing, the Athlii Gwaii Legacy Trust no longer exists.

Director Erica Reid sang the Haida national anthem.

The Chair shared that there's an Athlii Gwaii meeting on June 7<sup>th</sup>.

#### 7b. Grant Improvements

The Chair shared that there is a Grants Committee reviewing feedback from the public as well as recommendations from staff. He mentioned items that were currently under review by the committee, and noted that while their work is ongoing there are several changes to the Travel Assistance Grant which are effective immediately:

- Prepayment for the Travel Assistance Grant will now be made if the application is made at least 14 days prior to departure without receipts.
- Financial reporting can now be the submission of any receipts which reasonably demonstrate travel occurred (hotel, ferry, flight receipts).
- Players and chaperones for the Junior All Native can now apply for Travel Assistance if the team does not.

Question: On the website, why does the strategic plan only go to 2022?

Executive Director: There is a plan with deliverables, and it will be on the website soon.

Question: Has there been any work done to streamline the granting process?

Chair: Provided an overview of what was discussed earlier during agenda item 7b. Director Erica Reid recognized the speaker; at a past meeting, by speaking up about RBC investments that were not aligned with our mandate, she helped facilitate change.

Question: Is the reporting process changing, or just the Travel Assistance Grant?

Chair: Everything.

Question: Have you thought about an arts committee? Chair: Yes. It hasn't been discussed yet, but it will.

Question: For the Community Innovation grant and the Major Contributions grant, how is the grant selected as things are prioritized?

Executive Director: The priorities were chosen by the Board in 2020 but haven't been reviewed since. The COO

explained the current scoring process.

Question: (regarding the grant criteria) How do you know if it's the priority in your community? Director Bailey: Generally speaking, we go back to the communities, hear them and share them. Applications that support all islanders have a higher score.
